*Parliament met at 1.59 p.m. in Parliament House, Kampala.*

Hon. Apolot was a prominent member of the Forum for Democratic Change (FDC), was highly respected, and had a friendly personality. She was a servant leader who was deeply loved by the people of Ngora and colleagues in Parliament.

COMMUNICATION FROM THE CHAIR

**THE SPEAKER:** Honourable members, I welcome you to this special sitting. I am aware that since the last sitting of 16 December 2025, we had a busy festive season and equally an electoral process, which has been partially concluded, with more elections for special interest groups and the lower governments yet to happen tomorrow and in the coming days. I take this opportunity to thank all of you.

Her legislative track record was quite impactful. She served with distinction on the parliamentary Committees of Agriculture, Animal Industry and Fisheries, Equal Opportunities and National Economy. She was also an active member of the Parliamentary Sports Club, where she played netball.

It is also with a heavy heart that we convene here today to pay tribute to our own colleague, sister and friend, Hon. Stella Apolot Isodo,

**THE MINISTER OF STATE FOR AGRICULTURE, ANIMAL INDUSTRY AND FISHERIES (FISHERIES) (Ms Hellen Adoa):** Madam Speaker, allow me to congratulate you on bouncing back to the 12<sup>th</sup> Parliament. I also congratulate all the honourable colleagues who made it. To those who did not make it, God has more in store.

This is a motion for a resolution of Parliament to pay tribute to the late Hon. Stella Apolot

Isodo for her distinguished service to the nation, moved under Rule 58 of the Rules of Procedure of the Parliament of Uganda.

*“WHEREAS Parliament of Uganda received with sorrow the sad news of the death of Hon. Stella Apolot Isodo, Woman Representative, Ngora District, which occurred on Saturday, 17 January 2026 and;*

*WHEREAS Hon. Stella Apolot Isodo was a legislator and leader who served her nation with unwavering commitment and worked as a Woman Member of Parliament for Ngora from 2021 to the time of her death;*

*AWARE that Hon. Isodo served the people of Uganda in various capacities, including serving as a Community Development Officer in Concern Worldwide, Senior Development Officer in Concern Worldwide, Senior Development Officer in Self Help Africa and Agriculture Programme Manager in Vision for Teso Rural Development Organisation (TERUDO), where she played a key role in advocating for the aspirations of her people;*

*FURTHER AWARE that Hon. Isodo was a leading promoter of unity, as well as socio-economic transformation, especially for the Teso Subregion. She fostered unity and built consensus on important legislative priorities;*

*RECOGNISING that Hon. Isodo was a trained and accomplished agriculturist whose professional expertise positioned her to contribute effectively in Parliament on agricultural-related matters and advancement of agricultural policy;*

*FURTHER RECOGNISING that Hon. Isodo earned recognition for championing women’s rights through promotion of financial inclusion and self-reliance initiatives for women involved in rural subsistence farming and girl-child education, where all these initiatives created a more inclusive environment for women to benefit from national development programmes;*

*APPRECIATING that Isodo possessed unwavering passion for education, women and girls’ empowerment and national development, and her legacy is reflected in the diligent representation she provided for her constituents and the nation at large;*

*NOW, THEREFORE, be it resolved that:*

- 1. Parliament collectively conveys its deepest condolences to the bereaved family, relatives, friends, the people of Ngora and Uganda for the loss of a distinguished and exceptional leader of this country; and*

**THE SPEAKER:** Thank you. Is the motion seconded? It is seconded by the Leader of the Opposition, by Hon. Aber, and the Whole House. Thank you. Would you like to speak to your motion?

**MS ADOA:** Madam Speaker, as I mentioned earlier, before coming to Parliament, Hon. Stella Isodo was a very active person in the Ngora and Teso community, in mobilising farmers. During the National Agricultural Advisory Services (NAADS), she formed groups for women in agriculture, and she is one of the people in Teso who encouraged women to get involved in agriculture.

Many people got to know that agriculture was not just about going to the garden, but involved everything from the garden to the processing part, and making agriculture a business. For the first time, women who never used to go to Busia to take oranges as business got involved, and there was value for money through agriculture.

When Hon. Isodo came to Parliament - we who always attended the meetings of the Committee on Agriculture, Animal Industries and Fisheries -she advocated for the increase

of the budget of the agriculture ministry. She had a dream of stocking Lake Nyaguo with fingerlings because it is a satellite lake. She has died with such a dream which I – I really want to make sure that I put to the table for us as the Ministry of Agriculture, Animal Industry and Fisheries to fulfil her dream of stocking Lake Nyaguo.

I remember also how passionate she was about getting tractors to every district, and she made sure that Ngora got two tractors. I thank the late and the entire agriculture committee for always advocating for the agriculture ministry to be funded and to get a good budget. I thank you.

**THE SPEAKER:** Thank you, Hon. Adoa. Leader of the Opposition?

**THE LEADER OF THE OPPOSITION (Mr Joel Ssenyonyi):** Thank you, Madam Speaker. I rise to second the motion to pay tribute to our departed honourable colleague, the late Hon. Apolot Stella Isodo, former Woman Member of Parliament for Ngora District.

On behalf of the Opposition in Parliament and on my own behalf, I extend our deepest condolences to her husband, Mr Samuel Isodo, her children, the people of Ngora, and the Forum for Democratic Change political party that she belonged to.

The sudden death of Hon. Isodo at about 51 years is tragic and deeply painful. It comes at a moment when Uganda has barely emerged from a highly contentious election marked by killings, abductions, torture, and widespread fear among citizens who dared to participate democratically.

Hon. Isodo was no politician of convenience. As a committed Opposition leader, agriculturalist, and member of the Committee on Agriculture, Animal Industry and Fisheries, she consistently championed the issues of farmers, women, and youth – the backbone of our nation – whose voices are too often sidelined. Her leadership

rested on integrity, courage, and genuine closeness to her people.

Hon. Isodo was a gentle soul, but very firm on her stance about the kind of country she desired to see, as a leader and as a citizen. She desired to see a truly democratic state; a Uganda where the rule of law is respected, and where no one is above the law.

Hon. Isodo desired a country where the voice of the people is respected through the ballot, where leaders do not seek to occupy office at all costs, regardless of the implications.

**THE SPEAKER:** Honourable Leader of the Opposition, with due respect, can we stick to the objective of this sitting? On Tuesday, we have a sitting where we can discuss that. Let us first talk about my sister, Hon. Isodo, and then we shall come and pour out our hearts on the election in the next sitting. For now, let us talk about Hon. Stella Isodo.

**MR SSENYONYI:** Rt Hon. Speaker, I am seconding a motion about a leader whom I led on this side. I knew her aspirations; so, I am talking about somebody that I knew as well. I ask that I am given room to talk about my honourable colleague.

**THE SPEAKER:** Yes, not the election. Talk about Hon. Stella.

**MR SSENYONYI:** Madam Speaker, do you now probably want to speak on my behalf? I beg to be guided because I am seconding the motion, and I am speaking about my honourable colleague whose heart I knew, whose aspirations I know. Except if somebody wants to speak on my behalf, I ask that I am given room to speak as long as what I am saying is not unparliamentary. Thank you, Madam Speaker.

**THE SPEAKER:** Hon. Ssenyonyi, and I am saying this with respect, we are paying tribute to a fallen colleague. Let us talk about her legacy. On issues of politics, we will come back and talk about politics in this House.

**MR SSENKYONYI:** Madam Speaker, we are paying tribute to a politician; a politician who has been part of us. Everybody is going to have a chance to say what they would like to say about her. I am saying what I am saying about her through the lenses in which I saw her. I do not know why I am being barred and stopped from speaking about my colleague leader.

This is the tribute that I am paying to the honourable colleague who is lying here, who was a Member of Parliament on the Opposition side that I lead, somebody that I knew, whose politics I knew, whose heart and aspirations I knew. Please allow me to pay tribute to my honourable colleague. Thank you, Madam Speaker.

*(Text expunged.)*

So, I second this motion with the solemn hope that Parliament will honour her memory, not merely with words, but with action by defending democracy and insisting on transparency and restoring dignity to political participation in our country, Uganda.

**THE SPEAKER:** Thank you. As somebody who loved agriculture – Hon. Adoa – we should remember Hon. Isodo’s legacy by making women move away from subsistence agriculture to modern agriculture.

Also, Hon. Isodo, being a daughter of the soil, the tribute will not come with political statements. So, the political statements in this tribute, just know, will be deleted – because I have to give it to the family. I have a responsibility as one of the daughters from the subregion. Thank you.

**MS LUCY AKELLO (FDC, Woman Representative, Amuru):** Thank you, Madam Speaker. Allow me to pass my condolences to the family and to you, Madam Speaker, the people of Teso and this Parliament. From Amuru, we bring our condolences.

I would like to say that our sister was a true definition of what I call “Humility is not stupidity”. She was humble, but not stupid. She firmly and humbly stood for what she believed in.

As somebody who values family, I thank you, Mr Isodo, so much. I know that when Stella was sick, you were in the field campaigning for her. Thank you so much. *(Applause)* That is what family brings in politics. I encourage our friends here: Irrespective of what we go through, never ever leave your family. It is always your backup plan and your family should always be your priority.

Thank you, Mr Isodo and the children. I know you sacrificed so much to see her here. Please, celebrate her.

Finally, Madam Speaker, I was one of those who was approached by the late to sign up for the Parliamentary Forum on Cooperatives, and that is how much she loved agriculture.

I would like to challenge this Government, through the efforts of Hon. Isodo, to ensure that cooperatives thrive in this country. For those of us who have remained and have come back to the 12<sup>th</sup> Parliament, and are part of this forum, please, let us ensure that Hon. Isodo’s dream does not fade off, but continues.

I continue to pray for the family. May her soul rest in perfect peace. Thank you.

**THE MINISTER OF STATE, OFFICE OF THE PRIME MINISTER (RELIEF, DISASTER PREPAREDNESS AND REFUGEES) (Ms Lillian Aber):** Thank you, Madam Speaker. My condolences to the family of my sister.

Madam Speaker, allow me to thank you for the support you have been giving the family since we lost our sister. As Members of this House, we feel happy about how you always step in when a Member experiences a tragedy. Thank you so much, and please keep that up.

Madam Speaker, allow me to congratulate everybody who made it and even those who participated but did not make it. I still congratulate them. Politics is quite stressful.

My sister has been sick, but I also want to say that, probably, the stress of politics accelerated the condition that she had. **THE SPEAKER:** Hon. Aber, I had already made an order on that. So there is no need to speak about the Leader of the Opposition. It is not necessary.

Let us focus on the late Member. The matter of the Leader of the Opposition was resolved. Just withdraw the issue of the Leader of the Opposition.

**MS ABER:** I do withdraw, Madam Speaker. I would also like to add –

**THE SPEAKER:** Honourable members, let us be calm. We are in a mourning moment. We are sending off a friend, a sister, a person who has been sitting there. Today, it is her lying there, but tomorrow, it could be you or me. So, let us be calm.

**MS ABER:** Madam Speaker, I would also like to note that Hon. Achayo Juliet Lodou, who is the MP for Ngora County, has been working very closely with the Woman Member of Parliament, and I admired that. In most of our constituencies, people do not work together with the women Members of Parliament.

I am very happy that the two worked together, even on the issue of acquiring the tractors. They moved to these offices together and were pushing for all these issues to be achieved together. That is a good sign of unity.

Hon. Isodo was a member of the netball team where I was also very active. She would be there to bridge the gap in case of any conflict.

As my friend Hon. Lucy said, she was a peacebuilder. Sometimes when people see honourable members quietly seated behind, they think they do not have what to say; yet sometimes they sit because they want to listen more because it is not that everybody has to speak. Whenever you had a conversation with Hon. Isodo, you really saw an intelligent woman, somebody very humble who feared the Lord. We will really miss her. I pray that the Almighty God rests her soul in eternal peace. Thank you.

manner that I had never seen. She had such a cordial relationship with the police, to the extent that they would guide her and then the meeting would take place. In some instances, when we would go there with other leaders who did not like to agree with the police, she would shift the date and the venue.

I saw a leader emerging in her because she had the support of her people. Despite the politics that were monetised, she did not have resources, but she was able to make it to the 11<sup>th</sup> Parliament because of her love for her people.

She loved the women and the youth. The youth fought for her, supported her despite her gaps and challenges with resources. When she entered this Parliament, she really hoped that most of her dreams and desires would be achieved.

She worked across the political divide in ensuring that she would be able to achieve certain objectives and missions that the FDC would not be able to achieve. She is one of the people who remained committed to the party when nine of our colleagues decided to contest in other parties. She remained loyal to the Forum for Democratic Change. When the campaigns were going on, she was very calm and very humble, and she cooperated to ensure that there was harmony during the campaigns.

We would like to thank her children, her husband and the entire Forum for Democratic Change in Ngora for the support that you extended to her when she was bedridden. You gave her support. And thank you for having a peaceful election in that place. May God rest her soul in eternal peace.

**MR YUSUF NSIBAMBI (FDC, Mawokota County South, Mpigi):** Thank you, Madam Speaker. As the whip of FDC, I would like to make this statement to pay tribute to Hon. Isodo of Ngora District.

Today, we gather with heavy hearts to pay tribute to our beloved colleague and sister, the Hon. Apolot Stella Isodo. Her passing leaves a void in our lives, but specifically to the family which is before us here. We pay tribute to her and assure you that she was a different breed.

Hon. Isodo was passionate, specifically when it came to women's rights, education, sports and health care. She improved the lives of many in Ngora, but specifically for FDC. She bridged the gap because she was a humble lady.

As you are all aware – it is not politics – we had issues with many parties emerging. I remember one of the honourable members from Mityana said that I was in a refrigerator and that as such, they should not vote someone who is sick – I was in the ICU. I am here with a corset. Actually, I met the honourable colleague here when I was going for the operation. Incidentally, NUP insisted the man is a corpse and is in a refrigerator. She called me and told me to take it easy.

Normally, I do not take matters lightly, but I took it easy. I could not believe that the people we were seated with in the Shadow Cabinet would go around saying that “This guy is in ICU and in a refrigerator.” As I speak, I am still under strong medication.

I had to come to pay tribute and thank Mr Isodo for choosing a person who is different. (*Applause*) She was younger than me, but with just one word, she said, “Please, Yusuf, take it easy”, and I took it easy. I forgive Hon. Zaake and colleagues who attacked me by saying that I was in a refrigerator. I am still alive.

Beyond her role as Ngora woman representative, Hon. Isodo also served as the spokesperson of the entire Teso Region. That is a great achievement and responsibility.

We are going to miss her, as the FDC. We needed her guidance and participation. She had a lot of support on the ground.

Hon. Isodo had a lot of respect within our party. As the FDC's Parliamentary Whip, I served alongside her. We will miss her. However, our party is strong and committed to the values she advocated for. May her soul rest in eternal peace.

**THE SPEAKER:** Thank you.

Hon. Nsibambi, at least we sent you for that treatment. If Hon. Zaake said you were in a refrigerator, in our culture, when somebody dies, even if you have problems with them, you forgive them. Just forgive Hon. Zaake. He could have said it knowingly or unknowingly. Do not hold it in your heart.

**MS BETTY NALUYIMA (NUP, Woman Representative, Wakiso):** Thank you so much, Madam Speaker. On behalf of the people of Wakiso, I also join you and the entire country to mourn our colleague, a friend we have been with, a fellow netballer. Indeed, we have been playing in the same position, Goal Keeper (GK). She was a lady who could not harm or confront anyone for no reason. This is the person who lies in the casket before us today.

This is a humbling moment. It is written in the Bible – she was a fellow Christian – in Ecclesiastes 3, that there is a time for everything. We were born. That was the time for each of us to be born. As we see now, it was Hon. Isodo's time to die.

It is a humbling moment. We must all reflect on that day when we will die. What will the world remember about you?

As we talk about Hon. Isodo, I used to joke with her. She would always remind me that “My name is I-so-do.” She used to tell us, that Isodo is “I-so-do.”

What lessons do we pick from her? Are we remembered for being chaotic? Are we remembered for causing someone's death? Will we be remembered as people who stood for things that are not worthy, or could not correct what was wrong? Let it be a lesson.

As I summarise, we have already talked amongst ourselves that we should have something in place when a Member dies. Much as Parliament will contribute to the family, what is our contribution as Members? The Parliamentary SACCO is there, and each person contributes to it, but what fund do we have that is supposed to be taken on as a family.

Otherwise, as we remember Hon. Isodo, let us reflect more. What if it is you tomorrow? Did you contribute to another person's death? Did you abuse them? Did you cause someone pain as you lived on this earth?

I pray that we remember Hon. Isodo. Rest in peace, sister.

**THE SPEAKER:** Thank you, Hon. Naluyima. In terms of the benefits, the bereaved family have; there is a burial policy. Parliament takes charge of everything regarding burial, and whatever remains from the budget is handed over to the family.

Originally, A-Plus used to do everything: provide food and other things. Since these are political burials, now we make the area Members of Parliament sign for the difference in the money and sort it out with the local population so that A-Plus does not provide everything.

We also have the benefits of the late. Those benefits can only be discussed with the next of kin. We already have Hon. Isodo's next of kin. At an opportune time, we will call and explain to them their mother's benefits.

We thank Hon. Isodo. I have checked all the documents. She has the next of kin. Thank you.

Hon. Isodo and I were very close. We used to sit in the same position most of the time. I am so sad to hear of her demise.

Hon. Isodo was very passionate about agriculture. She fought for a tractor for Ngora District. She had promised to fight for more tractors for her constituency to empower women and many other young people in Ngora.

I pray that the Ministry of Agriculture, Animal Industry and Fisheries takes it up as part of our tribute here to send in more tractors to Ngora to ensure our sister's legacy remains burning in Ngora.

I also want to join my colleagues in thanking Mr Isodo. For us in Teso, we kept seeing him in the field even without his sweetheart, who was badly off.

We thank you so much, and I hope many of our husbands and men learn from him. Even without Hon. Isodo in the field, she was doing well. The voters were on her side.

I want to thank us for paying tribute to her. Please rest in peace, my dear mommy.

As a netballer, she played mostly wing defender, while I played wing attacker. We travelled together several times. I was a member of the Parliamentary Forum on Cooperatives, and when she invited Members of Parliament to launch the cooperative forum, I was the only Member of Parliament who turned up.

She was so passionate and to things that – (Interjection) - he reminds me that he also came, but they came later. Madam Speaker, I participated in the recently concluded elections, and I lost. I am thankful to the Almighty that I lost the election, and I am not in the casket.

When she participated, she had lots of hopes for her family, for her constituency; they are no more, she is gone. We pray that the Lord will receive her in honour.

Madam Speaker, it is extremely difficult for one to speak about a politician and not talk about politics at all. No wonder Hon. Yusuf had his own way to talk about it.

One of our colleagues has spoken about the stressful life of politicians that they go through. I want to agree; most times they accelerate conditions in us. That is why you find that around political seasons, politicians will die. I believe that the stress of elections also accelerated her condition.

Just think of a situation in which one of us is, to you honourable members, you may not know that in my constituency, 10 people were killed in a colleague's house. That is Hon. Muwanga Kivumbi. Suppose he had a condition, either pressure or cancer - we are told that cancer thrives under stressful moments - such a person, even his life might be pushed to an end faster than it would.

That reminds me, Madam Speaker, that some of us who have had time to have meaning and to cause action should always remember that for whatever we do, there is life after the life we are living, especially the Christians and Muslims, who believe that there is life after here, and so, we should be mindful of what we shall answer to the Lord, so that we do not cause pain and a lot of losses.

I join colleagues in praying that something should be done to the cooperative movement, which she was so passionate about, and revive the cooperatives - the Savings and Credit Cooperative Organisations (SACCOs) we are talking about are not the cooperatives that will help this country; it is the real cooperative movement.

I think after so many years, the fears that people in governance had in cooperatives should die away, and help our people and the agriculture sector by ensuring that people have a market for their produce, and easy money, so that they can help the agriculture sector.

We shall miss you, Stella. Your constituency and family will miss you forever. We pray that the Lord comforts them and receives you in honour. Amen.

cooperatives. Hon. Elijah is the Chairperson of the Teso Cooperative Union and Hon. Nandala is the Chairperson of Bugisu Cooperative Union.

We need to streamline the operations - Hon. Aisha, as a forum, you need to first look at what is happening in the current cooperatives so that we have credible cooperatives. Let us hear from Hon. Kirumira, and then the Member from Luweero.

I have known her for the last four years as a very humble person, and we have worked together closely as the Opposition.

However, as the Opposition, and knowing the circumstances under which she died, it would be very difficult to cross out or eliminate the fact that it was because of politics that our honourable colleague departed from this world.

This is because she died during a very hectic political period where so many of our

colleagues are still behind bars, and some of them have been killed. I can only imagine the stress and the pressure that she has been going through during the electoral process. At 51, gone too soon, rest in peace, Hon. Stella.

**MS BRENDA NABUKENYA (NUP, Woman Representative, Luweero):** Thank you, Madam Speaker. I rise to bid farewell to a colleague. Hon. Stella was a colleague in the Uganda Women Parliamentary Association (UWOPA), a good member. We also played netball together, and we were on the same side of the politics of this country.

Hon. Stella had decorum, was a very intelligent woman, and reasonable. When we were playing netball, sometimes we would not make the team, but for her, she was always calm and hoped for the next time, while the rest were throwing tantrums. I really appreciated her.

I know that we cannot give life, but if we could, we would give Stella her life back. I want to tell the family that she lived her life and served her people well. She always thought about the people of Ngora, and she was looking forward to bettering their lives.

She was a good legislator, cared for her people, and was always here. She was here to participate and speak for the people of Ngora unless she was either sick or doing something else.

**THE SPEAKER:** Thank you -

**MS NABUKENYA:** Because we would be in UWOPA, like Hon. Sarah said, she would always attend, and you would rely on her to participate. We thank God for her life and pray that she rests in peace.

**THE SPEAKER:** Thank you. There is something I want to put right. Hon. Stella fell sick, and she was even referred to India. She had a tumour, and she went for treatment -

Hon. Joan, you know that - she took a lot of time there.

When she came back, her life was not the same as she used to be. By the time I ordered for Hon. Stella to be brought from Soroti Hospital, her sugar levels - because she was also diabetic, she already had diabetic wounds.

I think the shock that she got was because they said they were going to amputate - because the wounds were too much. By the time she was brought here, the sugar level was around 26 to 28. That was it.

When we say that she died because of political pressure, it is not true. Actually, if politics kills, then we should not go into it because why should we get into something that kills. Let us hear from Elijah before I come to this side.

**MR ELIJAH OKUPA (Independent, Kasilo County, Serere):** Thank you, Madam Speaker. Today, this House bleeds. We are standing in a place of law and power, yet we are powerless before death. Her seat is empty, and her voice is gone. A servant of the people has been taken away from us.

We mourn the late Hon. Stella Isodo Apolot, the Woman Member of Parliament for Ngora District and a leader whose life was given, not spared in service. Hon. Isodo did not seek leadership for comfort or recognition. She came with fire in her heart, and duty in her bones. She carried the cries of her people into the chamber and refused to let them be ignored.

When she stood to speak, Ngora stood with her. When she voted, she voted with her conscience. When she disagreed, she did so with courage and truth. She believed that Parliament must never become detached from the pain of the people.

Hon. Stella was strong, but her strength was not rooted in pride but faith.

As a devoted member of the Pentecostal Assemblies of God's Church, she knelt before God before she ever stood before men. She prayed before she spoke. She trusted God even when politics was harsh and forgiving. Her Christianity was not a label; it was her compass.

To her family, the pain is unbearable. You may not know, she has left behind two sons and one daughter. The daughter is doing medicine at Nairobi University, the son is doing law, and the third born is doing engineering. She bore children with a brain.

To Ngora District, a champion has been silenced. To this Parliament, a conscience has been removed - *(Member timed out.)*

**THE SPEAKER:** Switch on.

**MR OKUPA:** Sorry! To her family, the pain is unbearable, to her church, a pillar has fallen, to Ngora District, a champion has been silenced, and to this Parliament, a conscience has been removed too soon. Her death is not just a personal loss, but a national wound, yet even in this deep sorrow, her life confronts us. It asks us hard questions: are we serving or surviving? Are we leading with conviction or convenience? Are we worthy of the people who sent us here?

Madam Speaker, Hon. Stella ran her race but did not finish it because she was tired but she finished because God called her home. Her work, courage and faith now speaks louder than her voice could. Her seat may be vacant, but her spirit still fills this House. Her legacy will challenge every one of us who still has breath to speak the truth, defend the weak and serve without fear.

On behalf of the people I represent in Kasilo County, and the people of Uganda, we bow our heads in honour of a fallen leader, a faithful Christian and a true daughter of Ngora. May the Lord she served receive her in eternal glory.

May her soul rest in perfect peace and may her life forever remind us that true leadership is a sacrifice. Rest in power, Hon. Stella Apolot. You served, you stood and finished well.

**MS CHRISTINE APOLOT (NRM, Woman Representative, Kumi):** Thank you very much, Madam Speaker. My condolences to the family, on behalf of the people of Kumi and on my own behalf.

Madam Speaker, allow me to thank you for always being there for us. When I was almost dying, you came to my rescue. *(Applause)* If you had not been there, I would not be speaking. May the good Lord bless you.

The time I was very sick is the same time Hon. Stella Isodo developed complications. When I started improving, I learned that my namesake was equally very sick, and I saw the sores. There was a time when my namesake could not put on shoes, but I did not know that she

also had diabetes. However, in that condition where we had lost weight, we had darkened. Hon. Isodo was very courageous. She would not behave as if she were sick, but rather like a normal person. She did not want to talk about her health. She wanted to behave as if she were very healthy.

My dear friends, the Stella lying before us here - we need to emulate her courage and strength. You can imagine if she were not courageous, Madam Speaker, she would not contest, but because she knew everything happens out of the will of God, Stella went ahead, in that condition and declared her candidature.

I beg that we give glory to God and thank her. She loved her party, the FDC. Every time Hon. Amuriat Patrick Oboi would have programmes to move around Teso, Hon. Stella Isodo would be there and would speak strongly about the FDC. Madam Speaker, I thank you so much.

**MS FLAVIA KABAHEMBA (NRM, Woman Representative, Kyegegwa):** Thank you, Madam Speaker. From Kyegegwa, I condole with you and my fellow members of the 11<sup>th</sup> Parliament, the country and the family.

I got to know Hon. Stella Isodo when she started raising issues about the rural women in Agriculture. When I was the Chairperson of the Committee on Gender, Labour and Social Development, she came close to me to find out whether in the sector there were any strategies and activities to empower the women who are in Agriculture, to make sure they effectively participate in economic activities.

What I used to get from the discussions with Hon. Stella was the rural women being empowered through agriculture by accessing resources. She knew how difficult it was for women to acquire land and that most of the time they would use land that was borrowed or belonged to their spouses. Therefore, they did not have enough to take care of what came out of the land.

She was looking at financing options for the rural women who are in Agriculture and the technologies available. She wanted to see whether the sector of gender had - *(Interruptions)* - had such business incubation programmes. She was looking at providing skills training and also strengthening the safety of Village Savings and Loans Associations (VSLAs) through co-operatives and improving markets for the women, but more so, improving family well-being and stability through food and nutrition.

Her passion for women and girls really calls for not only the Ministry of Agriculture, Animal Industry and Fisheries, but also the Ministry

of Gender, Labour and Social Development to tailor strategies that are going to improve women's effective participation, especially since most of the rural women are engaged in Agriculture. That is where they find - *(Member timed out.)*

**MS CHRISTINE AKELLO (NRM, Erute County North, Lira):** Thank you, Madam Speaker. Allow me to join the rest in remembering our sister Hon. Stella. I joined the Committee on Agriculture with Hon. Stella in 2021, and we have been close. She treated me like her maid because each time I sat next to her and did something wrong, she would bark at me. If I tried to find out what somebody said, she would tell me to be attentive. I remember that of Hon. Stella.

She also made me join the forum for cooperatives. I come from Ngora. Madam Speaker, I remember when we went to Bukedea, she picked me from your home and took me to Ngora. We had lost someone dear. She introduced me before the people, saying, "Christine -" she used to call me "my voter." "Please, do not come and vote from home", - my dad comes from Ngora - "You're my voter." I told her, "I do not know the language, so I will not come to Ngora, but I will contest in Lango." That is Stella; we have lost a friend and colleague.

I would also like to bring to your attention, Madam Speaker, that on the 12<sup>th</sup>, I was going to die before Hon. Stella during the just concluded elections. I was picked up by the Uganda People's Defence Forces (UPDF). They raided and drove me for 30 kilometres on a pickup and with bullets. I made noise to be rescued. Police pursued us - *(Member timed out.)*

**MS JANET OKORI-MOE (NRM, Woman Representative, Abim):** Thank you, Madam Speaker. I also join other honourable

colleagues in paying tribute to the late Hon. Isodo. I closely knew the late when I was the Chairperson of the Committee on Agriculture. We worked very well for three years.

What I know about her is that she was very objective, knowledgeable and resourceful to the extent that sometimes, whenever I got busy as a chairperson and the deputy was not around, I would assign her to chair the committee, and she did very well. She would even report on how she chaired.

For most of the laws that were handled by the Committee on Agriculture, like the Fisheries and Aquaculture Act, 2023, she contributed a lot, especially for the benefit of women.

This is the person lying before us today. I would like to send condolences to the people of Ngora, the family, the Teso community and the Ateker Cluster. Recently, while I addressing my voters, some of whom are Iteso, I kept – *(Member timed out.)*

That is how dedicated Hon. Isodo was and has been to the work that she does. Rest in peace, teammate. Rest in peace, Hon. Isodo.

Also, Section 9(8) of the Public Finance Management Act, 2015, and Rule 152(3) of the Rules of Procedure require Parliament to review and approve the National Budget Framework Paper by the 1<sup>st</sup> day of February of the preceding financial year.

Honourable members, considering that 1<sup>st</sup> February falls on a Sunday, the House will, therefore, consider the National Budget Framework Paper on Thursday, 29 January 2026. I hereby notify all the sectoral committees and the Budget Committee to work tirelessly and report to the House by that time or even before.

Honourable members, I would like to inform those who made it to the 12<sup>th</sup> Parliament that we will have the swearing-in ceremony on the 13<sup>th</sup>, 14<sup>th</sup>, and 15<sup>th</sup> of May. Please take note of these days.
