## FOURTH SESSION - 3RD SITTING - 1ST MEETING

# Wednesday, 19 June 2024

Parliament met at 10.00 a.m. in Parliament House, Kampala.

#### PRAYERS

(The Speaker, Ms Anita Among, in the Chair.)

The House was called to order.

COMMUNICATION FROM THE CHAIR

**THE SPEAKER:** Honourable members, I welcome you to this First Sitting of the Fourth Session of the 11<sup>th</sup> Parliament.

As you are aware, Rule 187(1) of the Rules of Procedure requires party whips to designate Members of the sectoral committees at the beginning of every session. Considering that Parliament essentially works through committees, it is imperative that the committees are functional at all times. Today, the House will designate Members of the sectoral committees to enable the continuation of application of their mandate of legislation, oversight and representation.

Honourable members, as you are aware, some of our colleagues are undergoing investigation. We held a meeting yesterday, 18 June 2024 in my office, with the heads of investigative bodies. We will get a report on the discussion we had, especially on the brutal arrest, not only of our Members, but on everybody outside there. We need to respect the rights of our citizens. On the same note, I watched three days back - I actually tried to call the Leader of the Opposition, but I think he was busy. He did not pick the call. It was unfortunate.

The Leader of the Opposition was doing his oversight role. The Opposition is supposed to check what the Government is doing. The Leader of the Opposition had gone to do his oversight role on Hoima Road, in Nansana, and his team was tear-gassed. That was unfortunate. Much as we are not supposed to interfere with the enforcement bodies like National Environment Management Authority (NEMA), by the time somebody starts construction, settles in a place for years and NEMA does not know that this is a gazetted area, then there is a problem.

We have malls that are built in wetlands. If somebody has gone to check and see the people in that area and you tear-gas them, where shall we ever get refuge? I would like to hear that from the Government because it was not called for.

Honourable members, our work is to support the citizens. In support of our citizens, we are supposed to understand and know what they are going through. In the process of us knowing and understanding what they are going through, allow us to do our work. I thank you for going to check on that team. At the same time, we should not be tear-gassed because we are doing our work as legislators.

The Parliamentary Pension Scheme has organised a half-day training for Members of Parliament for retirement planning. The meeting will be on 21 June 2024. Kindly attend. I thank you again for coming and we are starting the Fourth Session. We have only one year. Next year at this time, I know that I will have only five people in the House. *(Laughter)* It is only Kampala people who will be around -I can see the East African Legislative Assembly (EALA) on the other side. I urge all of you that even when we are in the Fourth Session, do not panic. Go back and be with your voters. Talk to them because you need to have a second, third or fourth term. Hon. Peter Mugema just started his first term. Therefore, I request you people to go back and talk to the voters. The counsel is afraid to go.

I do not see the minister. I expect a statement from the minister, but I want to first get one from the Leader of the Opposition. Honourable members, we will not prolong the reaction to the communication from the Speaker for one reason, I want to designate as we wait.

THE LEADER OF THE OPPOSITION (Mr Joel Ssenyonyi): Thank you, Madam Speaker. I appreciate you for raising the matter of what is happening in Lubigi, Ganda, Kawaala and the surrounding areas. These people reached out to me severally, including the local leaders, with a petition asking me to come and raise their matter in Parliament. However, I did not want to come to the Floor of Parliament and speak without all the relevant information. I did not want to speak out of ignorance. So, I went on a fact-finding mission together with Members of Parliament from that area, to listen to these people so that when I come to raise their issues, it is not just what I think. That is what took me together with the team that went to that area.

It is unfortunate, like you have said, Madam Speaker, that we were met with tear gas and live ammunition. We had not gone to fight. I had not even gone to tell those who were demolishing to stop. I do not have the powers. I had gone to listen to these people.

As you have mentioned, Madam Speaker, the Government should respond to a couple of issues. One, as you have rightly said, people settle in an area for years. I met old people. There is a man who said that he had been there for over 40 years. People have constructed huge structures and the Government is watching and doing nothing about it. They have settled there for years. Then you wake up now. Why? Help us understand. Was the Government sleeping on the job, and all of a sudden, has woken up? Were they waiting in a corner saying, construct your structures, spend all your money, get bank loans, then we come and demolish? Why are we operating this way? It is important that the Government responds to that.

Madam Speaker, these people are concerned about the double standards, right in the middle of that area is a police station. Everything around it has been demolished except the police station and the people are asking, why?

Right in the middle of that area is a fuel station, they are bothered and asking, why the double standards? They are saying that some settled in that area before the police station and the fuel station were built and they are trying to understand why the double standards.

The Government needs to engage the citizens to help them understand because these people are not saying that they are lawless and if anything, the Government acknowledges their presence there. For those that have had business structures, the Government has been collecting taxes from these people regularly so, help us understand, why operate in this way.

**THE SPEAKER:** Leader of the Opposition, when you talk about double standards and selective implementation, I would not mind the issue of the police station, but there are malls and you know that this is a wetland.

**MR SSENYONYI:** Not just malls, but factories also and they are asking, why is it that what is good for the goose is not good for the gander? The selective application of the law is problematic.

I would like the Government to help us understand, when shall we have a comprehensive plan to organise Kampala and beyond because when we touch a bit here and there; there are structures that keep coming up, including now in the city. However, they do not plan for drainage and that is why when it rains, the city floods, including outside Parliament here. Why? It is because of the disorganised-

**THE SPEAKER:** There is information for you from the chairperson Committee on Infrastructure.

**MR SSENYONYI:** I will take the information.

**THE SPEAKER:** Why is the road always flooded at Lugogo?

**MR ATWIJUKIRE:** Madam Speaker, I think you are alluding to the report about the construction that was happening in Lugogo on top of the trench. By the time Parliament went to recess, the report was ready and now that we are resuming, anytime from now, if the Speaker gives it space, it will be read.

THE SPEAKER: We are going to give it space and we discuss that report because we cannot build on the trench or build in wetlands. Leader of the Opposition, as the head of the Committee on Commissions, Statutory Authorities, and State Enterprises (COSASE), I would want you to ask your chairperson of COSASE to have an interaction with the National Environment Management Authority (NEMA) and find out the criteria they use.

**MR SSENYONYI:** Thank you, Madam Speaker. I would like to appreciate the colleague for that information and for the work they did as a committee. We look forward to having these engagements.

I took the initiative to reach out to the Executive Director of NEMA and I said, let us engage as leaders.

Have you reached out to these people to engage them? I encouraged him and his team to do so. If anything, that should have been the first course of action. First, engage these people, share your concerns with them and let them share their concerns with you; but that has not happened. Nevertheless, I will also follow up with COSASE. The final issue, Madam Speaker, alluding to your communication, is about the arrest of our colleagues. We are glad that some steps are now being taken in the fight against graft and corruption. That is a welcome move and our hope is that this shall be broadened and not just narrowed to a few.

However, to date, it has been five days since the Hon. Paul Akamba, Busiki County MP, was re-arrested after a court in this country had granted him bail. Re-arrested, not by police, because yesterday the spokesperson of the Uganda police force said he does not know his whereabouts.

Last evening I saw one of the lawyers saying that they have spoken to him, but they did not say exactly where he is and it bothers me. Hon. Paul Akamba belongs to the NRM and I lead this side, but it should concern me when the rule of law continues to be eroded because everybody will suffer. It bothers me even if it is an NRM member because we are all affected.

**THE SPEAKER:** We shall discuss that when he presents the report, but one thing I insisted to police is that if you want to arrest my Member, give the summons to me because originally they would want to pick people anyhow. And I also said that when you bring the summons, we want- not on hearsay that the least of 30, *sijuwi*-

No, tell me why exactly you want this person. I have the summons and as I speak now, Hon. Akamba is at the Criminal Investigations and Intelligence Directorate (CIID) headquarters answering charges on allegations on another case, but let us wait for a report from the minister.

**MR SSENYONYI:** I appreciate you, Madam Speaker. Finally, if they have another matter to do with a Member, the law is very clear on what an arrest is, and who carries out an arrest. These were plain-clothed men, wielding guns and putting him in a car. The same thing we have always complained about some of our supporters.

They are kidnapped, and put in drones and some people took it for granted. It is real and now happening to a Member of Parliament. It is wrong. Government, can we follow the law? When you conduct an arrest, the family and lawyers of this person must know where you have taken them, but if you take them to, God knows where, and nobody can follow up, let us stop eroding the rule of law in our country. Thank you.

Madam Speaker, where you have not heard leadership designated or proposed for designation, we are consulting and we shall come back on the Floor and fulfil the rules of procedure of this Parliament.

I beg to propose for the approval of Parliament. Thank you. **THE SPEAKER:** Thank you, Government. Whip? Counsel, is there any problem?

**MR NSIBAMBI:** Thank you, Madam Speaker. The Chief Whip is saying that where we have not heard designation of leadership, they are still consulting. The Order Paper was clear that the Whips are designating members of sectoral committees so, a party cannot come with its own proposal here, as if it is a final decision.

I think you must come up with your leadership. If you have no leadership –

**THE SPEAKER:** Honourable counsel, honourable members have been designated. You know, a committee has a right to choose whom they want as a chairperson. The committees are going to work. I think he is doing this on the principle of rotation; he wants to rotate Members.

**MR NSIBAMBI:** Madam Speaker, maybe I did not come out clearly. This session is specifically meant to close this chapter. Yes. So, if you have issues and you have no membership to fill, we can as well give you able leadership because we have it. *(Laughter)*

While the rule provides for re-designating a Member, and you are withdrawing them from the leadership, where are you deploying them, in terms of membership of a sectoral committee? Are they still hanging in the air? I also would like to remind you that this has to be with the approval of the House. (*Laughter*)

**THE SPEAKER:** Honourable members, listen.

**MR NAMBESHE:** Madam Speaker, my response is simplified by rule 196 -

**THE SPEAKER:** Honourable member, what most of these people are asking is that when you brought Dr Abed to be a chairperson, it was approved by this House. Tell them why you are withdrawing them, much as there are rules and you can withdraw them at any time you feel like.

Kwizera? *(Mr Ssenyonyi rose\_)* I am going to give you the opportunity, Leader of the Opposition. You will speak last. First wait and hear what people are saying.

**MR KWIZERA:** Madam Speaker, we operate under the law, and Article 21 of the Constitution is to the effect that we are all equal. The NRM, where Hon. Baryomunsi is a member of the Central Executive Committee (CEC), has designated and they have not given us any reason. *(Applause)* I do not know why we should now demand reasons from the other side. We are all equal. Thank you. *(Applause)* 

**THE SPEAKER:** (*Dr Baryomunsi rose\_*) Honourable members –

**MR SSENYONYI:** Madam Speaker, I actually have an answer for him.

**THE SPEAKER:** (*Dr Baryomunsi rose\_*) Let him answer.

**DR BARYOMUNSI:** Thank you very much, Madam Speaker.

**THE SPEAKER:** Can I have order? Honourable members – *Sseki? Sseki? Sseki? (Laughter)* 

**DR BARYOMUNSI:** Thank you, Madam Speaker. Hon. Kwizera has correctly said it. Yes, I am a member of CEC of the NRM party, as the vice-chairperson in charge of western Uganda. Indeed, when the Government Chief Whip presented names, he did indicate that the party is still consulting –(*Interjections*)- to fill some of the positions of some committees.

I can tell you that the consideration is that the CEC of NRM took a decision that we shall promote rotation in terms of leadership. Therefore - (*Interruptions*)- yes, it is important for us to explain. Therefore, we made a decision. (*Mr Olanya rose\_*) Are you from NRM? (*Laughter*) **THE SPEAKER:** [MR Olanya: "Order, Madam Speaker:"] No, there is also a point of order from Hon. Zaake.

**MR ZAAKE:** Madam Speaker, is Hon. Baryomunsi in order to insinuate that they have given a reason yet in some few committees, they have changed leadership and not given any reason?

**THE SPEAKER:** Honourable members, this is not a matter for debate. If you do not want the Member to be removed – it is a question. I do not know why you are talking.

**MR SSENYONYI:** Thank you, Madam Speaker. I think it is important that this House appreciates multi-party democracy and that is why the rules set it as such *-(Interjections)-*Madam Speaker, I beg to be protected.

**THE SPEAKER:** Honourable members, listen to the Leader of the Opposition.

**MR SSENYONYI:** Thank you, Madam Speaker. As I was saying, it is important that this House appreciates multi-party democracy, and that is why the rules prescribe as such. The rules say that re-designation can happen at any time and the rules do not say that there must be a reason. However, because the Chief Opposition Whip does that in consultation with the party, I will volunteer a reason.

Madam Speaker, you have always emphasised that committees have got to be active and that the leadership of committees have got to dispense their duty. For the committees that we head, as the Opposition: PAC (Central Government), headed by Hon. Muwanga Kivumbi, has been meeting severally; PAC (COSASE) headed by Hon. Sseggona and Hon. Alan Mayanja, has been meeting severally; and PAC (Local Government) headed by *Ladit* Olanya, has been meeting severally.

Madam Speaker, the Committee of Government Assurances and Implementation has not been meeting *-(interjections)-* and we think that, that is a very serious committee that has got to be active. They rarely meet and our thinking, as the persons in charge of these committees, is that we want these committees to be active. The Committee on Government Assurance and Implementation plays a critical role for this House.

When the Government makes promises, those promises are meant to be followed up. Therefore, we want this committee to be quite active. That is why –(*Member rose\_*)- he wants to give information; I will not take the information.

My point, Madam Speaker, is that we want the committee to also be active like the others are. So, using the powers given to us within the rules, that is why we are re-designating. Thank you.

**THE SPEAKER:** There is a motion. Honourable members, pursuant to rule 196, I put the question that the chairperson and the deputy chairperson of the Committee on Government Assurances and Implementation be re-designated, as proposed by the Chief Opposition Whip.

*(Members rose)* Honourable members – Hon. Francis, we are still getting an answer.

Honourable members, do you want to vote?

# HONOURABLE MEMBERS: Yes.

**THE SPEAKER:** The nays have it. You know we set a precedent when we removed Hon. Ojara Mapenduzi. I was also removed from the Committee on Public Accounts (COSASE) in the 10th Parliament because the then Speaker said no.

Honourable members, we are giving you one month of recess. We are concerned about our Members and we want them to come back to Parliament and because we want our Members to come back, you are going for recess and you will return on 23 July 2024.

The Business Committee meeting that we had organised for tomorrow will not be sitting because we have failed to get business yet. I now adjourn the House to 23 July 2024.

(The House rose at 11.31 a.m. and adjourned until Tuesday, 23 July 2024 at 2.00 p.m.)
