#### A BILL for an Act

#### ENTITLED

#### THE SUPPLEMENTARY APPROPRIATION BILL, 2020

An Act to make supplementary appropriation out of the Consolidated Fund under article 156(3) of the Constitution and section 25 of the Public Finance Management Act, 2015, of a sum of one trillion, seven hundred thirty-four billion, three hundred twenty million, eighty hundred fifty-eight thousand shillings only to meet additional expenditure for the Financial Year 2018/2019.

#### **BE IT ENACTED** by Parliament as follows:

#### 1. Commencement

This Act shall be deemed to have come into force on the 1st day of July, 2018.

# 2. Supplementary appropriation.

The supplementary appropriation out of the Consolidated Fund in respect of the first, second, third and fourth quarters of the Financial Year 2018/2019, for the purposes specified in column 1 of the Schedule to this Act, of the sums respectively specified in column 2 of the Schedule, is hereby allowed and confirmed.
