#### A BILL for an Act

#### ENTITLED

### THE APPROPRIATION ACT, 2020

An Act to apply a sum of twenty-nine trillion, nine hundred fifty two billion, seven hundred twenty seven million, six hundred fifty four thousand shillings out of the Consolidated Fund to the service of the year ending on 30<sup>th</sup> June 2021 and to appropriate the supplies granted.

# BE IT ENACTED by Parliament as follows:

### 1. Commencement

This Act shall come into force on the 1st day of July, 2020.

# 2. Issue of money out of the Consolidated Fund

The Treasury may issue out of the Consolidated Fund and apply towards the supply granted to the Government for the service of the year ending on the 30<sup>th</sup> June, 2021 the sum of twenty-nine trillion, nine hundred fifty two billion, seven hundred twenty seven million, six hundred fifty four thousand shillings only.

3. Appropriation.

The sums granted by this Act shall be appropriated for the services and purposes and in the amounts specified in columns 1 and 2 of the Schedule to this Act.

### 4. Expiry of appropriations.

- (1) Any part of the sums granted by section 2 of this Act which has been, or is issued from the Consolidated Fund on or before the 30<sup>th</sup> day of June, 2021 shall expire and cease to have any effect at the close of the financial year for which it is made.
- (2) A vote that does not expend any money that was appropriated to the vote for the financial year shall, at the close of the financial year, repay the money to the Consolidated Fund in accordance with section 17 of the Public Finance Management Act, 2015.
