**Bill No. 16***Supplementary Appropriation Bill***2024****THE SUPPLEMENTARY APPROPRIATION BILL, 2023****MEMORANDUM**

The object of the Bill is to provide for supplementary appropriation out of the Consolidated Fund under article 156 (3) of the Constitution and section 25 of the Public Finance Management Act, 2015, of a sum of two trillion, nine hundred and sixty three billion, one hundred and thirty one million, five hundred and twenty five thousand shillings only to meet additional expenditure for the financial year 2022/2023.

A BILL for an Act

**ENTITLED**

**THE SUPPLEMENTARY APPROPRIATION ACT, 2023**

**An Act to make supplementary appropriation out of the Consolidated Fund under article 156 (3) of the Constitution and section 25 of the Public Finance Management Act, 2015 of a sum of two trillion, nine hundred and sixty three billion, one hundred and thirty one million, five hundred and twenty five thousand shillings only, to meet additional expenditure for the first, second, third and fourth quarters of the financial year 2022/2023.**

**BE IT ENACTED** by Parliament as follows:

**1. Supplementary appropriation**

The supplementary appropriation out of the Consolidated Fund in respect of the first, second, third and fourth quarters of the financial year 2022/2023, for the purposes specified in column 1 of the Schedule to this Act, of the sums respectively specified in column 2 of the Schedule, is hereby allowed and confirmed.

**2. Commencement.**

This Act shall be deemed to have come into force on the 1<sup>st</sup> day of July, 2022.
